10/7/21 meeting notes

Beverly brought the meeting to order with 15 present.

Mary and Katie from Lake Oswego visited the group for the first time.

Joyce gave the treasurer's report:

• Checking/savings \$1,756.50 Money market 32,530.52 Total assets: \$34,287.02

We need to access the money market account, or it will go inactive; Joyce will take out \$100, just to keep it active. The checking account is growing slowly, and we have not needed to access the money market account for some time. We're not making much interest on it; we could move to a different bank that gives more interest, but Joyce is also looking into options for investing, as well.

It looks like the church has moved out from the grange basement. Bev will check with the grange to see if we can move the library cases into the basement. When we checked before, it would add \$20/month to our fees.

Class: Louise Colgan is scheduled to teach a Milanese class in March (3/18-20, Fri - Mon) - where will we hold the class? Is there enough interest to hold it? Would we prefer her Hungarian or color in Bucks classes? Seven votes for color in Bucks; not much interest in Milanese. Bev will ask if she would consider doing both Milanese and Bucks. She will also check to see if the grange room is available for that weekend.

Other alternatives: cancel Louise and hold a tatting quarterly group, instead; use the Hensel video classes from the library; meet in several homes for another "un-convention," or have one of our members teach a class. If the church is indeed gone, we might be able to use the grange over the weekend for gathering, or possibly the bank meeting room in McMinnville.

Lace Day: do we hold it in the spring, or move back to October? General feeling is that spring is better, 3rd weekend in May has been proposed.

Elections: the proposed slate is in the last newsletter, we vote at the November meeting.

New Christmas lace ornament lessons with Elizabeth Peterson is out from the Hensels. We need to buy it for the library - DVD or thumb drive? Thumb drive.

Salem Handweavers had extra paper bags at their last event at the Mill; Bev collected them to use at our lace days.

Demos: we only have the bead show and Magic at the Mill demos scheduled; Oregon Flock and Fiber has been canceled.

Meeting adjourned by Beverly, followed by show and tell, and more socializing.

PLS Minutes 11/4/21

Meeting called to order by Bev with 15 present.

The new Christmas ornament DVD by Elizabeth Petersen has been added to the library.

Joyce gave the Treasurer's report:

• Checking: \$1,601.71 Money market: \$32,431.06 For a total of \$34,032.77.

Louise's class this spring (3/18-20 weekend, but still tentative): we can hold the class at the grange on Friday and Saturday but we need a location for Sunday. Tommie Tank has volunteered her house (in Tigard) for Sunday. Bev will speak with Louise and firm things up for next month's meeting.

Slate of officers vote: Pat Farr moved to accept the slate, Tommie seconded and the motion carried unanimously.

Meeting suspended until the speaker arrives; show and tell until then.

Meeting reconvened for our speaker.

Joyce introduced Heath Cornick, financial advisor from Edward Jones, who spoke to us about what our options are for our money market account. Interest rates will remain low, at least for the next couple of years. We make just a few cents a month.

- 1. He advises that we split the money into thirds: cash for short term, a conservative mutual fund for long-term, safe growth, and a CD for the medium term.
- 2. He recommends American Funds Balance Fund for the long-term investment; he uses that for other non-profits. The fund's principle is protection of principal first, then growth, and to provide dividends. It averages 9-12%, but they typically expect 5-6%. It is currently an open fund, which means there are no limits on how many shares can be owned. No penalty to gains, but costs depend on how you buy it. 10 years or more, he recommends "A" shares, as that's a one-time cost of 5.75% (0.25% for operating costs out of that funds his services, fund managers, etc.). We could also move funds to a different mutual fund within American at no cost. (the more you buy, the lower the cost.)
- 3. Lynda asked about no-load funds: Vanguard offers those. We are not a 503c (IOLI is, but we can't use that). We are incorporated through the state (file 990 forms). Is that an issue? Heath said that it doesn't change what he's recommending.

The question was raised: what happens to the club's money if PLS dissolves? The charter says that the money goes to a selected non-profit, as determined by a vote of the group.

Next steps: do we move forward? Jean suggested that we form a subcommittee to review the options and make a recommendation to the club. Joyce and LeAnn will discuss details with Heath and present the plan at the December meeting.

11/13 demo at Willamette Heritage Center at the Mill, is coming up. Magic at the Mill is usually 12/19 - 22, but we don't have a lot of details, yet.

Meeting adjourned.




• Jean brought her new pieces in Fiandra. She's also been experimenting with different color combinations for a new Russian project and brought all her samples for us to see.


